Traci opened the meeting, welcomed everyone, and each attendee introduces themselves

Toni described an overview of the NOFA process including Tier 1 & 2, funding available, bonus projects, reallocation. Voluntary reallocation from S+C 1, S+C 2 and Twin Cities was discussed. This will allow all PSH, HMIS and Centralized Assessment grant to be in Tier 1 if these projects are prioritized this way.

Traci reviewed the project scoring tool and the outcomes scoring criteria.

Members agreed that they wished to reach a consensus for each scoring criteria under the scoresheet heading "Project Description and Grant Issues". The group reviewed the renewal projects first, then the new projects.

Prior to the meeting, each grant supplied information to the Prioritization committee based on the grant application and HUD monitoring and prioritization questions. These questionnaires were reviewed for each grant. Grant applications were available to clarify any needed information. As each was discussed, Traci reviewed the grant supplied outcomes for the APR scoresheet.

The group agreed that projects would be ranked based on the scoresheet scores. Ties would be settled by project utilization. Further ties would be determined by discussion of previous performance, reallocation and overall quality of agency supplied information.
